Asiaray Once Again Secures Exclusive Concession Rights to Operate Advertising and Media Resources of Kunming Airport

Further Expands Business Presence in Southwest China Ready to Capture Opportunities Brought by the Belt and Road Initiative

(Hong Kong, 10 July 2019) - **Asiaray Media Group Limited** ("Asiaray" or the "Group"; stock code: 1993), a leading out-of-home ("OOH") media company with a strategic focus on airport and metro line advertising, is pleased to announce that its indirect non-wholly owned subsidiary Yunnan Airport Asiaray Information Media Company Limited has entered into the Kunming Airport Agreement with Kunming Changshui International Airport Group Limited Liability Company ("Kunming Airport Company") to exclusively operate, manage, maintain and sell advertising and media resources located at Terminal 1 of Kunming Airport. Together with its existing media resources in Yunnan Province, winning the exclusive rights of operating advertising and media resources of Kunming Airport again will further strengthens the Group's business presence in Southwestern China, and reinforces its leading industry position in the Greater China Region.

Mr. LAM Tak Hing, Vincent, Founder, Chairman and Executive Director of Asiaray, said, "Through more than 25 years of efforts, Asiaray has built a solid business presence in the PRC with media resources network covering 39 cities. Among the media resources Asiaray is operating in 35 airports, we have been granted the exclusive operation right of media resources at 15 airports in Yunnan province. Kunming is the capital and the largest city of Yunnan province and Kunming Airport is one of the busiest airports in the world in terms of passenger traffic, and is expected to handle 43 million passengers in 2020. With the ongoing planning and development of the Chinese government's Belt and Road Initiative, Kunming is set to play an important role in the new gateway for the Bangladesh-China-India-Myanmar and the China-Indochina Peninsula corridors. The exclusive concession rights to Kunming Airport granted this time further broaden the Group's business role under the Belt and Road Initiative, which in turn benefits us in seizing the opportunities brought by future development of the local economies there.

It is also one of the two national gateway hub airports of China to Southeast and South Asia.
